*Tokyo, Japan – 2 October 2023 –* BeeCruise Inc. (BeeCruise), a subsidiary of BEENOS Inc. (BEENOS), has initiated support for integrating "magi," a trading card specialized flea market operated by Jiraffe Inc. (Jiraffe), with eBay. This strategic collaboration enables automatic synchronization between magi's platform and eBay, significantly enhancing cross-border e-commerce (CBEC) capabilities. Jiraffe, capitalizing on the increasing global demand for trading cards, launched the full-scale international sales of its trading card-centric flea market platform, "magi," in 2022. This expansion predominantly targets English-speaking markets.

Trading cards, which are highly sought after both as collectibles and investment assets, have experienced a surge in global demand. In Japan, the trading card market has been on a steady growth trajectory since 2018. By 2022, it reached a valuation of 234.9 billion yen, marking a substantial 132.2% increase from the previous year<sup>\*1</sup>. Furthermore, trading cards are consistently one of the most popular categories on Buyee, the CBEC proxy purchasing service

managed by the BEENOS Group.

BeeCruise has embarked on assisting stores in establishing their presence on eBay, targeting the burgeoning global demand for trading cards. Through the integration of "magi" with eBay, users who list their items on "magi" now have the opportunity to effortlessly extend their reach from local to global markets, tapping into areas with high demand worldwide. Initially, this eBay integration will encompass a select range of items, with plans to gradually expand the product offerings.
